


Issues and Limitations

- Cross border payments are slow and include high fees
- Monetization and entertainment features are mainly web 2.0
- There is no specific crypto token for the Creator Economy
- Creators are responsible to create their own discovery
- Creators need to invest time in research and education
- Starting Creators have high expectations and drop off quickly
- Starting Creators need to work with Creator Agencies
- RWA Staking is Not Yet Available in The Creator Economy
- Brands invest in creator and influencer marketing
- Platform (company) co-ownership doesn't exist for creators and partners

247X will be incorporated in Liechtenstein (Vaduz), Zug (Switzerland), Brno (Czech Republic), Dubai (United Arab Emirates) and the United States. We choose this incorporation structure because of its political stability, full transparency, advantageous tax regime, privacy laws and crypto friendly regulations to have global coverage for retail investors to participate during the 247XE STO (Security Token Offering).

247X Holding AG will be our parent company which has 100% ownership over all current and future business ventures. 247XE Holding AG will be fully tokenized meaning that all of its company stock will be available as equity tokens (\$247XE) to investors to invest through a STO which will be later listed on Tier 1 Crypto Exchanges (for public trading purposes).

For each Stake-To-Earn Asset (RWA - Real World Assets such as Creator Centers) we will set up separate corporate entities.



Tokenized Ecosystem

Next Generation Online Entertainment

The 247X Ecosystem will be based on disruptive On-chain Entertainment, Content Monetization, DeFi, Investment and Social Community features to connect and facilitate Creators, Fans, Partners, Brands and Investors.


This unique Next Generation Tokenized Ecosystem includes the integration of web3 use cases which will have a positive effect on the token valuation and market capitalization.

The first use cases are initially \$247X payment and payout methods combined with a mobile app and 247X Crypto Debit Cards.

Later we will apply native crypto wallet (\$247X) integrations within the 247X Ecosystem to adapt Web3.

Our main objective is to facilitate any type of Creator or Brand with content monetization, live communication, dynamic paywall, discovery and new unique features to monetize all their activities.

All stakeholders (Creators, Brands, Fans and Partners) have the ability to earn \$247XE (equity tokens) based on their achievements and performance.




247xe.com (named after the 247XE equity token) will be our main website and point of reference available for all our stakeholders.

Stakeholders will find on **247xe.com** everything they need to know about our Tokenized Entertainment Ecosystem and how they could benefit.

On-site we will publish multi-language information about all our activities, news, FAQs and a Support form.

For all stakeholders it's mandatory to register, activate their accounts and follow the KYC instructions (only applies for stakeholders who opt-in to receive funds).

After a successful authorized login session, users land on their Dashboard Page which provides access to KPIs and specific features per user role.





Monetization Features

For Creators and Brands

Creators make money by producing, publishing and selling content and by interacting with their followers and fans.

Creators are active on social media platforms to engage followers to join their profile and fan club (recurring subscription model) on a fan/creator platform as this is part to create their own discovery.

247X offers a Next Generation Web3 Ecosystem which provides a wide range of monetization, entertainment features and attractive incentives.

- Company co-ownership (247XE equity tokens) rewarded based on performance and achievements as a unique incentive
- Set up own pricing structure (paywall) for all monetization features and define privacy settings who can access their profile
- Highest revenue share (up to 87.5%), normally it's 80% !!!
- 68% base revenue share from all online earnings
- 13% from all online spendings from referred members and fans
- Up-to 6.5% from online earnings from referred creators (6 level commission structure) by create your own multi-level network
- Extra earnings by joining the Stake-To-Earn Program

Live broadcasted Voyeur Streams from connected Creator Apartments and 247X Creator Centers.

Members and Fans can access 24/7 live footage from their favorite Creators.

Participating Creators can expect higher earnings, optimized visibility and a better discovery by publishing live voyeur footage from their private premises.

Extra earnings distributed in \$247X Tokens are based on a algorithm to calculate the number of streamed hours, the number of live voyeur cams and rating from members and fans.

Voyeur Live Streams will be part of the Creator's Fan Club +Plus Subscriptions which will eventually result in higher subscriptions (recurring revenues).

NOTE:

The first 100 participating Creators will receive free broadcasting equipment.



Stakeholders will get full access to KPIs and statistics to see how their stakes perform including commission forecasting.

Commissions (20% from the annual profits) are by default distributed in \$247X tokens to all stakeholders.

In the upcoming 5 years we intend to open 247X Creator Centers before we execute our scaling plans.

Starting Creators can expect guaranteed paid programs.

Media Honeys will recruit, facilitate, operate and manage Creators to work either remote or in 247X Creator Centers.

All 247X Creator Centers will facilitate content production, live broadcasting facilities and pre/post production services.

Media Honeys will use Creator Agency services (PaaS) offered within our Partner Program to create proof of concept before connecting Premium Creator Agencies to use our services.

All payment and payout transactions are by default will be distributed in \$\$247X tokens.

5 months duration

Participating Creators can use all content production and broadcasting facilities in 247X Creator Center free of charge during the duration of the Creator Program.

Program Highlights

- Creators are hired as independent contractors (freelancers)
- Engaging profile and account creation, scheduled content shootings (photo sets and video clips) and visibility (traffic)
- Scheduled live broadcasted video chat sessions to interact with subscribers (members) and fans
- Each Creator will get an assigned Agent, who will update profile pages, maintain social media handles, communicate with followers and subscribers to engage them to start spending
- Monthly payouts (distributed in crypto or as bank transfers)


